# Request for Proposal - Security Audit Consultancy Services

Tree Aid, an organization committed to promoting environmental sustainability and community development, is seeking proposals from qualified and experienced security consultants to conduct a comprehensive security audit.

This audit will encompass the control environment, risk assessment, policies, and practices across our organizational units, with a primary focus on the Burkina Faso office. Additionally, oversight of other African offices, including Ethiopia, Mali, Niger, Ghana, and Senegal, will be a crucial aspect of the assessment.

## Guiding principles:

Tree Aid seeks to gain assurance on its security protocols to enable sustainable growth in an ever-changing context.

The audit process will reflect a comprehensive approach that takes into account a diversity of perspectives involving Tree Aid Senior Leadership Team and staff members, as well as the review of records.

The assessment will inform and guide future security measures, and be based on lessons learnt and best practices and a focus on four main elements:

1) Looking back to learn from the implementation of the current protocols

2) Looking at Tree Aid's major strengths and weaknesses

3) Benchmarcking Tree Aid practices within the third sector and the private sector

3) Looking forward where Tree Aid needs to focus to increase safety while continuing to operate in volatile areas.

## Objective:

The primary objective of this security audit is to evaluate the Tree Aid control environment, including risk assessment, policies, and controls. Furthermore, the assessment will extend to practices carried out by heads of units, country managers, country directors, directors, and security officers. The outcomes sought include a gap analysis in the control environment and practices specific to each office. Recommendations at both a granular and strategic level are expected to address identified gaps, ensuring alignment with local security levels.

#### Scope of Work:

The scope of the security audit will cover all employees within the organization, with a specific focus on the Burkina Faso office. Additionally, the audit will include oversight of other African offices, namely Ethiopia, Mali, Niger, Ghana, and Senegal. The selected consultant/consulting firm will be required to examine and assess the current security practices in place at each location.

## Process:

The proposed timeframe for this security audit will take place between February 2024 and April 2024. The selected consultant/consulting firm should ensure that the audit is conducted efficiently within this period, delivering timely and actionable insights.

#### Proposal Submission:

Interested consultants or consulting firms are invited to submit their proposals by February 16<sup>th</sup>, 2024. The proposal should include the following elements:

- 1. Detailed methodology for conducting the security audit.
- 2. Relevant experience and qualifications of the consulting team, highlighting expertise in security audits for international non-profit organizations.
- 3. Proposed timeline and milestones.
- 4. Budget estimate, including all associated costs.
- 5. Three professional references from organizations with similar security audit requirements.
