Purpose of the Role:

An exciting opportunity has arisen at Tree Aid for a Nature-based Solutions and Carbon Manager to join our growing organisation. Join Tree Aid as we expand our operations in a rapidly evolving field to further increase our impact and influence across the drylands of Africa. In this critical period in the global fight against climate breakdown, this newly created position will play a key role.

We are recruiting a confident and experienced professional, passionate about the protection or restoration of natural ecosystems, to provide technical expertise to support the development and implementation of high-quality, impactful nature-based solutions (NbS) projects in Tree Aid countries of intervention (Burkina Faso, Ethiopia, Ghana, Mali, Niger and Senegal). They will be involved in evaluating the carbon sequestration potential, marketing, trading and sale of resulting carbon credits and on how to channel climate finance and carbon markets in the most effective, equitable and sustainable manner to the benefit of the communities Tree Aid serves. As a result, the individual will need to be comfortable working with data at different scales and levels of certainty and analysing forest growth and yield models to produce estimates of environmental commodity/credit generation.

This role will also work closely with our Advocacy Advisor to help amplify the impact of our work, deliver on our international influencing strategies and in helping Tree Aid achieve lasting change across the drylands of Africa.

Tree Aid is open to applications from individuals with varying years of experience and expect that there will be considerable growth opportunities in this role with exposure to investment underwriting, investment management, and investor engagement.

Key responsibilities

NbS Project Development, Carbon Financing and Implementation (70 %):

- Technically lead and backstop NbS projects during the whole project life cycle
- Lead pre-feasibility carbon analysis (forest growth and yield modelling) of different NbS promoted by Tree Aid to assess realistic long-term projections of forest carbon potential as well as delivering high-impact social and environmental co-benefits
- Use a full range of spatial (GIS), database, spreadsheet, programming and other tools to process, calculate, analyse and perform quality control on raw and finalised forest carbon data
- Analysis of forest inventory and related data using standard approaches and software
- Design and evaluate forest inventories and sampling protocols for estimation of carbon and other forest inventory variables
- Keep up to date on new methodologies under different third-party certification standards, tools, and remote-sensing technologies that influence carbon and ecosystem markets
- Set-up and manage the Monitoring, Reporting and Verification (MRV) plan and ensure that credit issuance timelines are met. This will require working closely with external consultants, verifiers, and contractors, Designated Operational Entities (DOE)
- Develop and maintain productive partnerships with all project stakeholders including community-led organizations; research scientists; contractors; and local, state and federal government agencies to advance projects
- Develop understanding of relevant regulatory policies in project regions and trends in voluntary and compliance carbon markets related to nature-based carbon removal
- Identify and develop new projects, programs, and partnerships; successfully and regularly bring in new projects conceptualized with these partners

Technical Advice, Capacity Building and Learning (20%):

- Lead on technical advice and mentoring across country programmes and partners to train, supervise, and strengthen capacity development of staff.
- Support and share key learning and help to create an environment for innovation.
- Support Advocacy work to influence international processes and sustainable investment mechanisms for NbS.

Representation (10%)

- Serve as a recognized subject matter expert in the field
- Represent Tree Aid at relevant for related to sustainable finance and investment for NbS, in UK, UN and multi-lateral lobbying as required,
- Represent Tree Aid-UK at relevant meetings, panels and workshops.
