Purpose of the Role:

We are recruiting a Policy and Advocacy Advisor to strengthen Tree Aid's advocacy and influencing work across our projects and campaigns. We are seeking a confident and experienced advisor with a track record of impactful advocacy and a keen interest in media and strategic communications. By working closely with country management and the UK Operations team the incumbent will develop new areas of policy research, provide high quality and responsive social, economic and political analysis and provide strategic support on policy, advocacy and influencing across all Tree Aid strategic goals.

The role will have a predominant focus on the Great Green Wall for the Sahara and Sahel Initiative (GGWSSI) and its implementation by national governments and in helping Tree Aid become more visible and play a more active role in the UNFCCC climate change negotiations and climate change adaptation and the UNCCD.

This role will work closely with our communications team. Hence we are looking for someone with a keen interest in media and strategic communications alongside significant advocacy experience.

We strongly value diversity and welcome applications from applicants from all backgrounds. We particularly encourage applications from women and people with a Black, Asian or minority ethnic (BAME) background.

Policy Research and Analysis

- Support UK Operations and Country Management teams in overall external development policy analysis.
- Maintain and share up-to-date knowledge and understanding of key policy and political developments relating to our campaign areas and their potential effects on implementation of strategy.
- Lead on policy and practice related research and analysis and its documentation.

Advocacy

- Oversee the development, implementation and coordination of advocacy and influencing strategies across our projects and campaigns
- Support TREE AID UK and our country programmes in planning and delivering their advocacy work and ensure that all project plans include influencing objectives.
- Ensure alignment of country programmes policy objectives with TREE AID's strategic priorities and ensure effective harmonisation of planning and management with TREE AID UK.
- In coordination with the Communication Manager, assist with the development of a communications strategy that supports TREE AID's influencing objectives.

- Coordinate the production of briefing papers, policy position and public communication materials.
- Build support for our proposals amongst target stakeholders and decision-makers in the UK Government, Parliament and civil service, overseas governments, and other international institutions
